*Note: Mason Trailer Rentals LLC provides a commercial insurance policy that covers damages to the camper during the rental period less any deductible. Renters that will be towing the trailer will need to provide evidence that their insurance carrier will extend liability during the rental period in the event of an accident.

Reservations

Deposits:

- 1) A non-refundable reservation fee is required to secure dates requested. This amount is applied to the final balance. The deposit is due when the application is delivered or sent. Payment can be via check or PayPal (by request).
- 2) At time of pick-up (or delivery) a credit card authorization form is completed as a damage/cleaning deposit. No charges will be made against the card unless the cleaning and/or damage requirements in the rental agreement are not met.

Cancellations: All cancellations must be made by phone.

Camper Pick-up or Drop-off

- 1) **Pick-up:** Renters must schedule a pick-up time. Renter must participate in a demonstration of the camper features and safety features. Renters should allow for one hour for the demonstration.
- 2) **Delivery Drop-off** (camper trailers only): Mason Trailer Rentals LLC offers delivery of trailer unit to your destination campground. Delivery must be pre-arranged to insure staff is available for delivery on requested dates. Renter must participate in a demonstration of the camper features and safety features. Renters should allow for one hour for the demonstration. The delivery/pick-up fee is to be paid with balance.
- 3) **Rental Charges:** Rental balances are due prior to pick-up or delivery. Payment is by cash, check or credit card. Final payment can be made via PayPal or Square by request PRIOR to pick-up or delivery. Any credit card payment requires an electronic processing fee.
- 4) **Driver's of tow vehicle:** All drivers of tow vehicle must have a valid driver's license, be at least 25 years of age and be present at time of pick-up. **NO EXCEPTIONS.**
- 5) **Tow Equipment:** The tow vehicle must have the towing capacity to tow requested trailer, have a framed Class 3 hitch (for campers) and a functioning electronic brake controller (for campers).
- 6) **Liability:** Renter agrees to accept liability for ANY damages caused to the camper by renter or renter's family and/or guests. Damage includes, but not limited to, damage to camper in any way or damage to any appliances and/or equipment furnished. If damages are in excess of security deposit, renter agrees to reimburse Mason Trailer Rentals, LLC for costs incurred to repair or replace damaged items. Should Mason Trailer Rentals, LLC insurance cover damages, renters are responsible to pay insurance deductible and possible additional costs as outlined in Rental Agreement.

Pets: Pets are NOT allowed in any unit at any time. Evidence thereof will result in cleaning/damage fee.

Smoking: Smoking is NOT allowed in any unit at any time. Evidence thereof will result in cleaning/damage deposit.

Camper Returns/Pick-up:

- 1) Return Time: Trailers must be return by the agreed upon return date and time in the condition outlined in the Rental Agreement (3:00pm on scheduled date). A \$25 charge is required for each hour the trailer is return is late from the agreed upon return time. The charge will be taken from the Damage/Cleaning Deposit or billed with the Credit Card Authorization signed at delivery/pickup.
- 2) Refunds are not available for early returns.
- 3) Pick-ups: The trailer will be picked up for the renter’s campsite at the pre-determined date and time for trailers that were delivered. The trailer is required to be ready for towing at the pre-determined time. A \$50 charge is required for each hour the trailer is not ready for pick-up from the agreed upon time. The charge will be taken from the Damage/Cleaning Deposit. At time of pick-up the renter will have all personal belongings out of the trailer and space for tow vehicle to attach to trailer.

Rental Agreement:

A rental agreement with full terms and condition will be executed at delivery or pick-up. A copy can be emailed prior to upon request. Renter agrees to execute the Rental Agreement at time of pick-up or delivery.

I have read and understand the terms of this Rental Reservation Application. I understand that all additional materials I am provided during the rental are part of the contract. I understand that should I violate the terms of this Rental Reservation Application or the Rental Agreement, I will forfeit any and all deposits. I understand that the information on this Rental Reservation Application is correct.

- 1) I understand my tow vehicle must meet towing requirements for camper requested.
- 2) The tow vehicle has a frame mounted class 3 hitch.
- 3) The tow vehicle has a functioning electronic brake controller.
- 4) I understand that I must provide evidence that my insurance company will extend liability coverage for the rental period.
- 5) I understand that the camper must be returned cleaned as outlined in the “Cleaning Checklist”.
- 6) It is the renter’s responsibility to determine the distance to campsite utilities prior to rental. Campers are equipped with standard connection lengths for electric (25’) and water (25’). Distances greater than standard require additional components and advance notice. Additional components are made available in order that that requests are received.
